Reminger Co., LPA Named a Corporate Citizenship Award Finalist by Columbus Business First

The Corporate Citizenship Awards are part of a larger initiative to celebrate companies who are "doing good works to make Central Ohio a better place," according to the business publication. More than 160 companies submitted information about charitable monetary donations, in-kind contributions and volunteer hours from the past year. Finalists were selected in four different categories: Small (1-49 employees); medium (50-99 employees); large (100-249); and extra-large (250+ employees). Winning organizations will be announced at an event held June 21st at Grandview Yard.

"We believe strongly in supporting the communities in which we live and work," said Columbus office Managing Partner Ronald A. Fresco. "We look for ways to make meaningful contributions to those organizations and causes that our staff and attorneys feel a connection."
